4)Debt Service: disbursements for debt principal retired, interest paid, paying agent's fees, and other cost of administering city's debt

5)Total Governmental Activities and Expenditures: Public safety, Public works, Health and social services, Culture and recreation, Community and economic development, General government, Debt service, Capital projects

6)General obligation debt: is backed by the "Full faith and credit" of the city. The city promises to pay the annual debt service on that indebtedness through annual property taxes.

7)Revenue debt financing: is backed by payments received by the city for specific services or users or specific revenue sources

8)Special assessment bonds are paid back from assessments levied against owners of property who benefit from the improvement

9)General obligation debt limit: found from 5% of actual value of taxable property
